n the last 22 years, the Media Foundation for West Africa (MFWA) has led efforts to promote media freedom and provided capacity building to hundreds of media organisations and journalists across all countries in West Africa. Through its work, the MFWA has helped to position the media as key actors and supporters of democratic consolidation and national development in the sub-region.

With the emergence of new trends in freedom of expression and media development coupled with the constant advancement in technology, the media landscape in the sub-region continues to witness rapid changes with significant implications.

#### **Welcome Address**

ear Esteemed Guests,
It is my greatest honour and privilege to welcome all of you to this year's edition of the West Africa Media Excellence Conference and Awards (WAMECA 2019). Your enthusiastic response to our invitation, especially those of you who have travelled from across Africa and beyond, is testimony of your commitment to advancing media excellence in West Africa.

Over the last three years, WAMECA has become West Africa's biggest convening that deliberates on the critical challenges confronting media development and freedom of expression in the region. The annual Journalism Awards at WAMECA has also become the most credible, coveted and respected regional journalism awards on the continent of Africa.

The last two decades have witnessed significant growth in the media industry in West Africa, thanks to the transition to democratic governance and the ever increasing access to the internet. The growth in the media industry obviously presents a great opportunity for the consolidation of the region's relatively nascent democracy.

Over the last three years, however, there have been massive crackdown on the gradual gains made towards the freedom much needed for independent journalism to thrive. Physical attacks, arbitrary arrests and detention, and other forms of harassment and violations against journalists have become rampant and normal across the region. In the last two years, for example, there

have been close to 300 different incidents of violations against journalists, media organisations and activists.

Another major emerging development that has the greatest potential of eroding media credibility and fueling further attacks on media and other rights activists is the phenomenon of "fake news."

Across the continent, journalists, particularly those working with online media, and social media activists, continue to face various forms of attacks from authorities who accuse them of peddling false or fake news. Such acts of violations have included complete or partial shutdown of networks, news website takedowns, blocking of social media platforms, arrests and detentions, among others. These violations become more prevalent during important national events such as elections.

While the deliberate deployment of fake news for electoral or other purposes pose a threat to electoral credibility and peace, the solution to the phenomenon, cannot and should not be a crackdown on online and journalistic expression. The solution can only come from dialogue, sharing of ideas and best practices, and the application of rights-based and other forms of legally acceptable practices. This explains why we have chosen to focus this year's WAMECA deliberations on the theme: Social Media, Fake News & Elections in Africa.

While creating this platform to discuss this critical issue, WAMECA also recognises journalistic excellence and this is what the awards component of WAMECA does, honouring the journalistic stars of West Africa. It is our hope that the WAMECA awards will continue to motivate winners to do more and inspire others to want to even do better.

We are sincerely grateful to all our esteemed WAMECA supporters, particularly, the Embassy of the United States in Ghana, Facebook, Access Now, Hewlett Foundation, DW Akademie, MTN-Ghana, Stanbic Bank Ghana, & Alisa Hotel.

## **Pansy Tlakula**

Advocate Pansy Tlakula is a former Special Rapporteur on Freedom of Expression and Access to Information and former Chairperson of the Working Group on Specific Issues related to the work of the African Commission. For 10 years, since 2005, she worked as member of the African Commission on Human and Peoples' Rights (ACHPR). In 2015, she was appointed Chairperson of the ACHPR, a mandate she held until 2017. Advocate Tlakula also formerly served as the Chairperson of the Electoral Commission of South Africa.

Currently, Advocate Pansy Tlakula is the Chairperson of the Information Regulator of South Africa. She holds a B. Proc degree from the University of the North (now University of Limpopo), an LL.B

degree from the University of the Witwatersrand, and an LL.M degree from Harvard University. In 2006, she was awarded an Honourary Doctorate in Legal Studies by the Vaal University of Technology.

Advocate Tlakula has held other high-profile positions in academia, public and private sectors including Chancellor of the Vaal University of Technology, Chairperson of the Board of the National Credit Regulator, Chairperson of the Council of North West University, National Director of the Black Lawyers Association, Senior Law Lecturer at the then University of Bophuthatswana (now North West University), and one of the founding Commissioners of the South Africa Human Rights Commission.



## **The Africa We Want Project**

# Mobilising Civil Society Support for Implementation of the African Governance Architecture

The Africa We Want project is an initiative that seeks to promote the implementation of the African Charter on Democracy, Elections and Governance (ACDEG) in Africa. The project is being implemented by a consortium of 14 influential Civil Society Organisations (CSOs) that operate at sub-national, national, sub-regional and regional levels.

The 14-member Consortium is made up of ActionAid Country Offices in Denmark, Ghana, Mozambique, Nigeria, Sierra Leone, Tanzania, Uganda, Zambia, Zimbabwe, and five regional organisations - East African Civil Society Organizations' Forum (EACSOF), Mass Public Opinion

Institute (MPOI), Media Foundation for West Africa (MFWA), West African Civil Society Forum (WACSOF), and SADC Council of Non-Governmental Organisations (SADC - CNGO).

The African Union (AU) adopted the African Charter on Democracy, Elections and Governance (ACDEG) in 2007, during the 8th Ordinary Session of the Assembly of Heads of States and Governments. It is the AU's main normative instrument that sets standards for better governance across the continent.

The Africa We Want Project is funded by the European Union.

We have had to deal with various scams on customer promotions, recruitments, corporate social initiatives, etc. It is also interesting to note how the fabricators take all the time to make their stories look very real. From our experience, we have seen some of them mimicking the IVR of our call center, another used the front page design of the newspapers to promote their fake stories. The effects of fake news propagated through social media are enormous and besides the emotional trauma and personal losses people make, it could have unimaginable consequences.

In order to curb the spread of fake news via social media, we believe that people need to be news-literate and crosscheck facts before forwarding or sharing any information they receive on social media.

Corporate organizations need to be more vigilant and strengthen their communications to ensure that quick responses are given any time fake news items are published. Again, we should arm our customers with information and create more avenues for our customers to reach us. Customers should probe more when they receive any information before acting on them.

MTN remains committed to its vision to lead the delivery of a bold new digital world to our customers hence our continuous investments in the network and the development of product and services to ensure that our customers live a connected lifestyle.
